B. Criteria

The Page Society Hall of Fame honors a lifetime of leadership in the profession. Members of the Hall of Fame have had a significant impact on the enterprises they have served or counseled, not only through communications strategy, but on business strategy and policy as well. They are leaders in the mold of Arthur W. Page, who was the first senior public relations executive to wield such influence on the course and fate of the enterprise he served.

Nominees should have served a minimum of 15 years in a senior level corporate communications position for a private or public sector enterprise or public relations agency. Nominees should have demonstrated commitment to the Page Principles and should have done all or most of the following:

- Served as an engaged member of senior management.
- Influenced the organization to act in the public interest.
- Enhanced the reputation of the organization.
- Developed capable staff recognized for their excellence.
- Served as a mentor to younger professionals.
- Made major contributions to the profession through significant participation in professional organizations, and/or by writing, speaking, or teaching.
- Been recognized by peers as an influential leader and/or received other major professional awards and honors.
- Held significant leadership roles in major community organizations.
